

# ASX ANNOUNCEMENT GROWTHPOINT PROPERTIES AUSTRALIA (ASX Codes: GOZ and GOZN)

## **GOZN Top 20 Holders and Range of Units**

Growthpoint Properties Australia ("Growthpoint") confirms that 40,830,314 stapled securities under its renounceable rights offer announced to the market on 30 October 2013 ("Rights Offer") have been allotted. These "New Stapled Securities" were issued at \$2.45 each raising just over \$100 million.

Trading in the New Stapled Securities is expected to commence tomorrow (Thursday, 12 December 2013) under the code 'GOZN' to reflect that these securities will be entitled to a pro-rata share of any distributions for the half year ending 31 December 2013. "GOZN" stapled securities collapse into "GOZ" on 23 December 2013.

Holding statements for the New Stapled Securities are expected to be despatched tomorrow (Thursday, 12 December 2013).

As the Rights Offer was significantly oversubscribed, excess applications were subject to a scaleback in consultation with the underwriter, Merrill Lynch Equities (Australia) Limited. Securityholders should confirm their holding before trading in New Stapled Securities. Any securityholder who sells New Stapled Securities before receiving confirmation of their holding in the form of a holding statement does so at their own risk.

Reports showing the range of units and the top 20 holders of the New Stapled Securities follows.

The Rights Offer follows Growthpoint's \$50 million placement on 30 October 2013 (also heavily oversubscribed). Placement securities are currently trading under the code 'GOZNA' to reflect that they will be entitled to a pro-rata share of any distributions for the half year ending 31 December 2013. "GOZNA" stapled securities collapse into "GOZ" on 23 December 2013.

Following the collapse of "GOZN" and "GOZNA" on 23 December 2013, a total of 475,705,269 GOZ stapled securities will be on issue.

Following the placement and Rights Offer, Growthpoint Properties Limited of South Africa's holding in Growthpoint has now reduced to approximately 63.5%. Growthpoint Properties Limited followed its rights under the Rights Offer but did not participate in the placement.
