This latest launch coincides with the launch this month of branded platforms for Premium Wealth Management and Interprac. These three major licensees authorise more than 230 financial planners Australia wide with \$5 billion of funds under advice across all firms. HUB24 is now actively working with these financial planners to support the promotion of the white labels to new and existing clients.

Commenting on HUB24's recent success Mr Andrew Alcock, Chief Executive Officer said:

We have developed three new white labels concurrently over the last quarter, allowing rapid deployment for our new licensee clients. Each has their own range of professionally managed portfolios designed to provide clients with improved investment and tax outcomes whilst generating substantial cost savings and efficiencies".

The agreement with TFS takes the number of HUB24's white label offerings to 8, with more than 41 licensees now utilising the next generation platform. Funds under administration are continuing to grow on the platform with HUB24 reporting an increase to \$556m at 31 October from \$384m at June 30 2013 (44.5% growth).
