MONADELPHOUS CONTRACTS UPDATE

Leading engineering company Monadelphous Group Limited (ASX: MND) ("Monadelphous") today announced it has secured maintenance services contracts and contract extensions with major customers in the resources and energy markets. The contracts have a combined value of approximately \$140 million and comprise of:

- A three-year Maintenance Services Framework Agreement with BHP Billiton Nickel West. This
 agreement includes a two-year extension option, and covers both mechanical and electrical
 services across all of BHP Billiton Nickel West's operations in Western Australia (WA);
- A two-year extension of an onsite services contract at BHP Billiton's Olympic Dam operation in South Australia, where Monadelphous has been working for more than 20 years;
- A new one-year contract with Rio Tinto Coal and Allied for dragline and shovel shutdowns at their Mount Thorley Warkworth and Hunter Valley Operations sites in New South Wales. The agreement includes extension options of up to four years; and
- A one-year extension to the onsite services contract with BP at Kwinana, WA.

"These contracts and contract extensions will support our recurring revenue base and reflect the importance we place on developing and maintaining long-term relationships with customers in our core markets," Monadelphous Managing Director Rob Velletri said.
