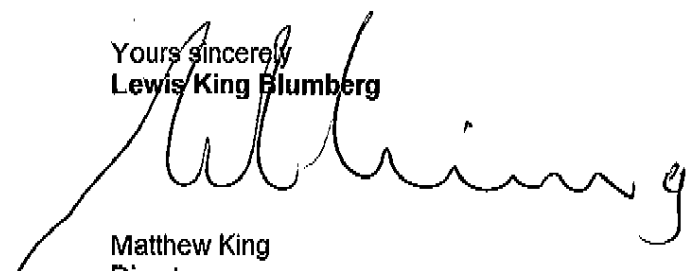
On behalf of Calculator Australia we enclose a notice of change of interest of substantial holder.

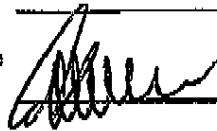

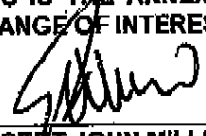

DIRECTIONS
