### Monadelphous Secures Facilities Management Services Extension

Leading engineering company Monadelphous Group Limited (ASX:MND) (“Monadelphous”) today announced it has been awarded an extension to the facilities management services contract associated with the Gorgon Project operated by Chevron Australia Pty Ltd. The contract extension, valued at approximately \$200 million, is to continue the operation and maintenance of construction facilities and utilities on Barrow Island, Western Australia.

The scope of services includes the operation and maintenance of water and wastewater treatment plants, power generation and distribution systems, as well as the management and maintenance of various buildings, vehicles, plant and equipment. The contract was first secured in November 2009. More than 200 people will continue to be employed as a result of the contract.

“This contract extension demonstrates our capability to provide a wide range of multidisciplinary maintenance and construction services and underlines the importance we place on long-term delivery to our customers,” Monadelphous Managing Director Rob Velletri said.

The Gorgon Project is operated by an Australian subsidiary of Chevron and is a joint venture of the Australian subsidiaries of Chevron (47.3 percent), ExxonMobil (25 percent), Shell (25 percent), Osaka Gas (1.25 percent), Tokyo Gas (1 percent) and Chubu Electric Power (0.417 percent).
