Leasing Activity Update and Sale of Brisbane Property

Industria REIT is pleased to announce that it has executed a lease extension with Radio Frequency Systems (RFS) which currently occupies 10,647 sqm at 32-40 Garden Street, Kilsyth. The RFS lease had an expiry date of December 2017 which has been extended to December 2024, increasing the property's WALE from 3.0 years to 10.0 years. RFS is a subsidiary of Alcatel Lucent.

As a result of the RFS lease extension and other successful leasing transactions, the future lease expiry profile of Industria REIT has been significantly improved.

With this transaction the Industria team has delivered over 16,500 sqm of new leases and renewals across the portfolio since 30 June 2014. Incentives for these transactions were at or below market levels and have been negotiated both internally and with the assistance of leasing agents.

Settlement of 53 Brandl Street, Brisbane Technology Park

We are pleased to confirm the completion of the sale of 53 Brandl Street for \$10.25 million. The transaction was previously announced to the Australian Securities Exchange on 23 September 2014. The sale proceeds will be used to repay debt.
