CLEANSING NOTICE

We refer to the issue of a convertible security by Novogen Limited (**Novogen**) on 20 December 2013. Pursuant to a notice of conversion of a portion of the convertible security representing in aggregate \$75,000, Novogen issued 986,843 ordinary shares to Merrill Lynch (Australia) Nominees Pty Limited ACN 003 925 031 FBO Hudson Bay Master Fund Limited on 5 December 2014 (**Shares**).

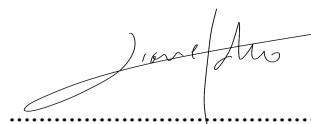
