However, the Appendix 3Ys lodged on 17 September 2014 and 6 October 2014 inadvertently omitted an acquisition of 58,917 fully paid ordinary shares and 1,329 fully paid ordinary shares respectively, due to an administration oversight which was recently identified. Accordingly the enclosed Appendix 3Ys have been amended to correctly reflect the Director's notifiable interest.
