US\$20 million in Additional Funding Secured

- Taurus is entitled to 61,425,061 unlisted options over unissued fully paid ordinary shares, for nil consideration and exercisable at A\$0.40 with half being issued at execution and half pro-rata on facility drawdown above US\$5 million. The options expire on 31 December 2018 and have no vesting conditions.

The Taurus Facility puts Base on a sound financial footing, providing a source of additional funding for the Kwale Project should it be needed, the means to satisfy the US\$15 million addition liquidity covenant and US\$5 million in corporate funding.
