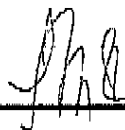

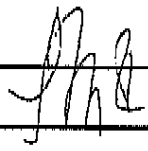
DIRECTIONS

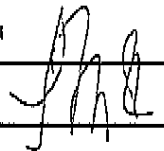
