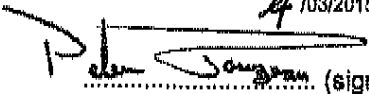
DIRECTIONS

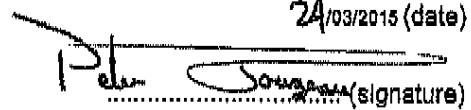
