Please find attached a Form 604 disclosure in relation to the substantial shareholder interests held by BlackRock, Inc. and its subsidiaries named in the Annexure to the Form 604 ("**BlackRock**") in Monadelphous Group Ltd (ASX: MND) ("**Company**").

On 20 March 2015, there was a change in the interests held by BlackRock which resulted in an increase of its voting power in the Company to 20.77%. This increase occurred as a result of the quarterly rebalancing of a number of indices maintained by third party index providers which required various BlackRock index tracking funds to increase their holdings in the Company in order to realign their portfolios to the revised indices.

The increase in BlackRock's holding to more than 20% of the voting power in the Company was a result of index tracking and not an intention to hold more than 20% of the voting power of the Company. Upon becoming aware of the fact that BlackRock's holding had reached 20.77% of the voting power of the Company, BlackRock promptly sold shares in the Company to reduce its voting power in the Company to less than 20%.
