#### **COMPLETION OF PLACEMENT TRANCHE 2 SHARE ISSUE**

Sino Gas & Energy Holdings Limited (ASX: SEH, "Sino Gas" or the "Company") advises that settlement of the second tranche of the Placement announced on 23 April 2015 was completed today via the issue of 298,362,897 shares at \$0.16 per share to raise A\$47,738,063. Attached is the requisite Appendix 3B and Cleansing Statement pursuant to Section 708A of the Corporations Act.

This completes the Company's recent capital raising initiatives having raised A\$84.1 million (before costs), consisting of A\$80m from the Placement and A\$4.1 million from the Share Purchase Plan.

#### About Sino Gas & Energy Holdings Limited

Sino Gas & Energy Holdings Limited ("Sino Gas" ASX: SEH) is an Australian energy company focused on developing Chinese unconventional gas assets. Sino Gas holds a 49% interest in Sino Gas & Energy Limited ("SGE") through a strategic partnership completed with MIE Holdings Corporation ("MIE" SEHK: 1555) in July 2012. SGE has been established in Beijing since 2006 and is the operator of the Linxing and Sanjiaobei Production Sharing Contracts (PSCs) in the Ordos Basin, Shanxi province.

SGE's interest in the Linxing PSC with CUCBM is 64.75% and 49% for the Sanjiaobei PSC held with PCCBM. SGE has a 100% working interest during the exploration phase of the PSC, with SGE's PSC partners being entitled to back-in upon Overall Development Plan (ODP) approval, by contributing development and operating costs in line with their PSC interest.

The PSCs are located in the Ordos Basin and cover an area of approximately 3,000km<sub>2</sub>. The Ordos Basin is the second largest onshore oil and gas producing basin in China. The region has mature field developments with an established pipeline infrastructure to major markets. Rapid economic development is being experienced in the provinces in which Sino Gas' PSCs are located and natural gas is seen as a key component of clean energy supply in China.

Sino Gas & Energy Holdings Limited (ASX: SEH) was admitted to the Official List of ASX in 2009.

## NOTICE UNDER SECTION 708A(5)(E) OF THE CORPORATIONS ACT
