BBI'S RAIL AND CONVEYOR PROJECT APPROVED BY THE WA MINISTER FOR ENVIRONMENT

Rutila is pleased to announce that approval has been given from the Western Australian Minister for Environment for the BBI Rail and Conveyor Project in the Pilbara region of WA. The approval, with relevant secondary approvals, allows Rutila to construct and operate a railway line of approximately 160 km, which together with a conveyor system of approximately 40 km in length will link the Flinders Pilbara Iron Ore Project (PIOP) with the proposed BBI Port. The approval caters for ancillary infrastructure to construct and operate the rail system to deliver ore from PIOP to the port. Ministerial approval for the BBI Port was originally granted in August 2013, and then upgraded in January 2015 for the BBI Port expansion to enable Rutila to export ore from third parties through the proposed transhipment facilities.

Executive Chairman Nicholas Curtis said:

"We are pleased to have received Ministerial approval for the BBI Rail and Conveyor Project. It is a critical piece of infrastructure and paves the way for Rutila to advance the vision for our project into a reality."
