MOU LAUNCHES FULLY UNDERWRITTEN \$11.0M CAPITAL RAISING

Modun Resources Ltd (ASX.MOU) ("MOU") is pleased to announce that it has lodged a fully underwritten prospectus with ASIC and ASX to raise \$11.0m under a public offer ("Offer") at an issue price of \$0.15 per share (post a 1:50 consolidation). The Offer has been fully underwritten by Blue Ocean Equities, lead manager to the Offer.

The underwritten Offer meets one of the conditions required for MOU's acquisition of LiveTiles Holdings Pty Ltd, as previously announced by MOU on 27 April 2015 ("Acquisition").

MOU reserves the right to accept oversubscriptions of up to \$1.0 million through the issue of up to 6,666,667 shares at a post-consolidation issue price of \$0.15.

A shareholder meeting of MOU to approve the Acquisition, capital raising and all related resolutions will be held on 30 July 2015.
