REQUEST FOR TRADING HALT

IMX Resources Limited (ASX: IXR, TSX: IXR, IXR.WT), (the “**Company**”) requests a trading halt in the trading of the Company’s securities, effective immediately.

In accordance with Listing Rule 17.1, the Company provides the following information in connection with this request:

- A trading halt is necessary as the Company expects to shortly make an announcement to the ASX, providing further information on its joint venture over the Ntaka Hill joint venture with Loricatus Resource Investments (Fig Tree) (the “**Ntaka Hill JV**”);
- The Company requests that the trading halt remains in place until the earlier of the commencement of normal trading on Friday, September 4, 2015 or an announcement in relation to the Ntaka Hill JV;
- The Company is not aware of any reason why the trading halt should not be granted; and
