#### SG Fleet Group Limited – Cleansing Notice and Appendix 3B

This notice is given by SG Fleet Group Limited (**Company**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

The Company has today issued 9,100,000 ordinary shares (**Shares**) as part consideration for the acquisition by SG Fleet Management Pty Limited of all issued shares in nlc Pty Limited (**Acquisition**) as announced to the market on 17 November 2015.
