Disposal of 7 Brandl Street at premium to book value

APN Funds Management Limited, the Responsible Entity of Industria REIT ('IDR' or the 'Fund'), has exchanged an unconditional contract to sell 7 Brandl St, Brisbane Technology Park for \$25.5 million, significantly ahead of the forecast book value of \$23.15 million.

The sale follows the successful lease-up of long term vacancy, and a lease extension to the major tenant to December 2020 to create a 5.2 year weighted average lease expiry. This activity created the opportunity to liquidate the asset and crystallise value creation.

Alex Abell, Fund Manager of Industria REIT said: "This is an outstanding outcome for Industria's unitholders, with the \$25.5 million sale price representing a premium exceeding 11% of the forecast book value. The sale follows significant asset management success across various buildings at BTP to enhance value and create capital recycling opportunities, a credit to the expertise and focus of the APN Property Group management team."

After taking into consideration sales costs, NTA accretion is forecast to be ~\$2.2 million, or 1.8 cents per unit.

Settlement is scheduled for 31 July 2016, with proceeds to be used to repay bank debt. There will be no impact on FY16 DPU guidance.
