Amended Appendix 3B and Listing Rule 7.1

Gascoyne Resources Limited (**Company**) advises that it has inadvertently exceeded its capacity to issue equity securities without security holder approval under listing rule 7.1 by 16,581,119 equity securities. The non-compliance with listing rule 7.1 is due to the Company's miscalculation of its listing rule 7.1A capacity at the time of completing the 18 April 2016 Appendix 3B resulting in the Company exceeding its available listing rule 7.1 capacity.

Ratification by security holders of the issue of the 16,581,119 equity securities at the upcoming General Meeting will not refresh the Company's capacity to issue securities without security holder approval under listing rule 7.1.

The Company has provided ASX with an undertaking not to issue any equity securities without security holder approval until 29 November 2016, unless the issue comes within an exception in listing rule 7.2. The Company has also given an undertaking not to seek shareholder approval pursuant to listing rule 7.1A to issue securities under the additional 10% placement capacity at the 2016 Annual General Meeting.
