Preliminary Appendix 3B for Auswide Bank shares to be issued in respect of the YCU scheme of arrangement

As announced earlier today, the scheme of arrangement (“**Scheme**”) under which Auswide Bank Ltd (“**Auswide Bank**”) will acquire all of the shares in Queensland Professional Credit Union Ltd (trading as YCU – Your Credit Union (“**YCU**”)) has now become effective.

Attached is a preliminary Appendix 3B setting out the maximum number of new Auswide Bank shares to be issued pursuant to the Scheme. The exact number of new Auswide Bank shares to be issued is expected to be known on the Scheme record date (which is expected to be 11 May 2016).

Auswide Bank will lodge an Appendix 3B on the implementation date of the Scheme (which is expected to be 19 May 2016) reflecting the exact number of new Auswide Bank shares to be issued in respect of the Scheme.


