Form 604 (Notice of change of interest of substantial holder) in relation to Greencross Limited (ASX: GXL)

Attached is a Form 604 (Notice of change of interest of substantial holder) in relation to Greencross Limited (Greencross) dated 8 June 2016 given by the substantial holders outlined in the attached Form 604.

It notes that the substantial holders have increased their aggregate voting power from 15.42% to 18.83% as a result of amendments to the swaps between Gavia L.P., Tourmalet Pty Ltd (the Carlyle entities) and Goldman Sachs Financial Markets, first disclosed in the substantial holders' Form 603 dated 13 February 2016, to include an option for those swaps to be physically settled. This increased the voting power but not economic interest of the substantial holders in Greencross.

This is a temporary and technical increase in the substantial holders' interests, triggered as part of the process of the Carlyle entities selling their stake in Greencross. As disclosed in the substantial holder notice lodged by Credit Suisse on 7 June 2016, the Carlyle entities, TPG Asia VI SF Pte. Ltd, and Prebest Pty Limited have entered into a block trade agreement with Credit Suisse Australia Limited in respect of the sale by them of 11,644,664 Greencross shares. A further substantial holder notification will be provided following settlement of the sales contemplated by the block trade agreement.
