## Cleansing notice under section 708A the Corporations Act 2001 (Cth)

On 7 June 2016 Adherium Limited ACN 605 352 510 (**Company**) (ASX: ADR) announced the exercise of options (via the lodgement of an ASX Listing Rules Appendix 3B) and the resulting issue of 519,714 fully paid ordinary shares in the capital of the Company (**Shares**) at the issue price of \$0.134039 per Share. The Company also applied for quotation of the Shares on ASX.

The Company gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (Act) that:

- 1. the Company issued the Shares without disclosure to investors under Part 6D.2 of the Act;
