Correction to FY 2017 distribution guidance payment amounts

The announcement on 17 June 2017 stated that subject to current market conditions continuing, the estimated distribution guidance for the year ending 30 June 2017 was 21.3 cents per stapled security.

The announcement should have stated the FY 2017 distribution is expected to be paid through the distribution of 10.5 cents per stapled security in February 2017 and the distribution of 10.8 cents per stapled security in August 2017.
