
NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Cth)

This notice is given by RCG Corporation Limited (ACN 108 096 251) ("**RCG**") under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (the "**Act**").

RCG gives notice as follows:

- (a) RCG advises that it has issued 36,842,105 fully paid ordinary shares at an issue price of \$1.425 per share to the shareholders of Hype DC Pty Limited in connection with the acquisition of Hype DC Pty Limited by RCG under the share sale and purchase deed dated 4 July 2016 between RCG and the shareholders of Hype DC Pty Limited;
- (b) the shares referred to above were issued without disclosure under Part 6D.2 of the Act;
- (c) this notice is given under section 708A(5)(e) of the Act;
- (d) as at the date of this notice, RCG has complied with:
