ISSUE OF NEW SHARES

In accordance with ASX Listing Rules, Academies Australasia Group Limited (ASX:AKG) provides as follows a New Issue Announcement (Appendix 3B) in respect of 800,000 new, fully-paid ordinary shares (the 'New Shares').

The issue is made in respect of an agreement with the vendor of Transformations – Pathways to Competence and Developing Excellence Pty Limited, trading as Skills Training Australia, for the third tranche payment ('the Final Payment'), to comprise:

- the issue of 800,000 new ordinary shares, representing settlement of \$200,000 of the Final Payment; and
- 60% of the Final Payment (less \$200,000) to be paid by 28 February 2017 and
- the balance of the Final Payment to be paid by 30 June 2017.

The Final Payment was previously agreed to be a cash payment in full on 31 August 2016.

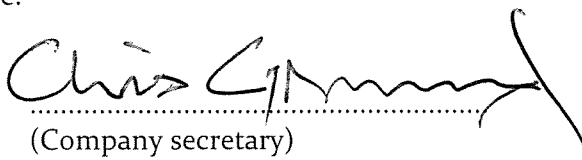
