Please find an Appendix 3Y relating to the notifiable interests of Ms Fran Hernon attached.

The Appendix 3Y relates to the issue of securities to Ms Hernon under the terms of the Company's Dividend Reinvestment Plan (**DRP**) as at 18 March 2016 and 22 September 2016.

### Half Year Allocation

Infomedia acknowledges that Ms Hernon's shareholdings increased by 833 shares as a result of participation in the Company's DRP for interim dividends, paid on 18 March 2016 (Half Year Allocation).

Under ASX Listing Rule 3.19A.2, an Appendix 3Y relating to the Half Year Allocation should have been lodged with the ASX by Friday 25 March 2016. Regretfully this did not occur. The Company did not become aware of the change until 22 September 2016 when it was notified of Ms Hernon's increased interests arising from payment of the final dividend of even date. Our enquiries reveal that the omission to notify the Company was an inadvertent oversight.

The Company complies with Listing Rule 3.19B, and the guidance contained in paragraph 12 of Guidance Note 22, by entering into written agreements with each Director, requiring that the Director provide sufficient information to the Company to enable it to comply with its obligations, including those arising under ASX Listing Rule 3.19A.

The Directors of the Company are aware of their obligations to disclose notifiable interests, and the omission in this instance was a rare aberration. The Company routinely complies with Listing Rule 3.19A, and believes that sufficient controls and arrangements are in place with its Directors to ensure that the Company is able to meet its disclosure obligations under ASX Listing Rule 3.19A. The Company has communicated with the Directors directly about this matter and does not propose to take any further steps at this time.
