ISSUE OF SHARES AS FINAL DEFERRED CONSIDERATION ON ACQUISITION OF THE LIGHTNING DISTRIBUTION BUSINESS

Melbourne, Australia – BWX Limited (ASX: BWX)

In the accompanying Appendix 3B the Company provides details in relation to the issue of 210,291 ordinary shares in the Company, subject to voluntary escrow until 30 June 2017, which have been issued in accordance with the agreement to acquire the business of Lightning Brokers which completed on 31 March 2016.

The deferred consideration was payable contingent upon the Lightning business achieving an EBITDA greater than \$2,250,000 for the financial year ended 30 June 2016. The Directors have determined that Lightning has achieved this target and accordingly the deferred consideration is to be settled by the issue of ordinary shares, issued at \$4.654 per share, being the 30 day VWAP prior to the date of issue of the deferred share consideration.
