### Hong Kong Network Update

Superloop Limited (**ASX: SLC**) is pleased to provide the following updates.

#### Hong Kong Network

Superloop has achieved a major milestone with the completion of the installation and testing of the first 110km backbone fibre cable network (1000 cores of fibre) in Hong Kong.

Mr Slattery, Chairman and CEO of the Superloop Group said, “The achievement of this milestone is an exciting step as Superloop prepares to launch its newest network in Asia Pacific. The Hong Kong network, when combined with the existing Singapore and Australian networks, uniquely positions Superloop as the only provider with significant metropolitan fibre infrastructure across these three major markets.”

The installation and testing of the 2<sup>nd</sup> ring cable (an additional 1000 cores of fibre) is currently 96% complete and remains on track for delivery in early 2017. A formal launch of the network will take place on 6<sup>th</sup> December at Capacity Asia Conference in Hong Kong.

#### TKO Express

Superloop is also pleased to advise that the construction of the TKO Express Cable has commenced. Superloop has established and cleared the Chai Wan site in preparation for the drilling works which provide the dedicated duct infrastructure for bringing the cable ashore. In addition, the 1,728 core double armoured TKO Express submarine fibre-optic cable has now been manufactured and is being shipped from Australia to Hong Kong. The Company is equally excited by the progress being made on the TKO Express project, which also remains on track for completion in early 2017.
