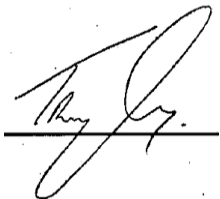

**PROTECTED INDUSTRIAL ACTION (B2015/1146)**

The CEPU, as bargaining representative for its members who are employees of AGL Loy Yang Pty Ltd who are currently covered by the *Loy Yang Enterprise Agreement 2012* ("the Agreement"), and who will be covered by the proposed enterprise agreement or agreements to succeed the Agreement, hereby gives notice pursuant to s414 of the *Fair Work Act 2009* of the intention of the aforesaid employees to take the following employee claim action:

1. A stoppage on the performance of all work for a period of one (1) hour commencing at 7am on Sunday 25 December 2016;
2. A ban on overtime for a period of one (1) hour commencing at 7am on Sunday 25 December 2016;
3. A ban on issuing and/or receiving electrical/mechanical permits for a period of one (1) hour commencing at 7am on Sunday 25 December 2016;
4. A ban on responding to break downs for a period of one (1) hour commencing at 7am on Sunday 25 December 2016; and
5. A ban on performing higher duties for a period of one (1) hour commencing at 7am on Sunday 25 December 2016.
