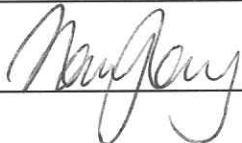

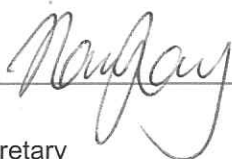

DIRECTIONS
