REMSAFE extension program completed at Anglo American's Zibulo coal mine in South Africa

Orbital Corporation (ASX:OEC) ('Orbital' or the 'Company'), via its wholly owned subsidiary REMSAFE Pty Ltd (REMSAFE), has successfully completed an extension program of its market leading electrical isolation system at Anglo American Zibulo Coal Mine in South Africa.

Anglo American contracted REMSAFE in 2015 to install a remote isolation system on the site's 16km long overland conveyor that transports coal from the Zibulo mine to the Phola Processing site. In late March 2017 REMSAFE completed an extension program automating further aspects of the overland conveyor isolation.

The REMSAFE system has successfully reduced isolation times from around 2 hours prior to the installation, to just a few minutes. Automation has significantly enhanced the safety of the conveyor operation through improved ease of use, simplification of process and by limiting personnel exposure to the danger of arc-flash.

The REMSAFE remote isolation system is an innovative state of the art solution as it reduces the risk of arc flash exposure, isolation of wrong equipment, human error and improves safety of personnel. The system is user friendly and has simple isolation and lockout steps.

REMSAFE is a world class safety rated system that enables isolation and lockout to be performed at convenient locations along the conveyor. The system has multiple layers of protection and complies with IEC Functional Safety Standards. The remote isolation system demonstrates how the use of technology can achieve a significant step change in safety and efficiency.

Having successfully completed the extension work program at Zibulo, REMSAFE is continuing discussions with Anglo regarding further applications of its systems to enhance safety and productivity at other Anglo operations.

Orbital's CEO, Mr Terry Stinson, commented: "The Zibulo installation demonstrates the significant benefits REMSAFE can deliver to mining companies from both a productivity and safety perspective. We are looking forward to concluding discussions with Anglo with regard to future opportunities."

The potential pipeline of new projects continues to grow, with REMSAFE actively engaging with the Australian and South African mining industry on further system sales. Other recent inbound enquiries include the potential for REMSAFE systems to be installed on a light rail system, a US copper mine and a Canadian iron ore mine. REMSAFE is working with the proponents of these projects to assess the potential for REMSAFE's isolation systems to be deployed.
