Convenience Retail's initial portfolio will comprise 66 properties, valued at \$308 million, predominately located on Australia's favoured eastern seaboard. The portfolio offers a long weighted average lease expiry and contracted annual rent increases providing the REIT with a strong level of income security. Convenience Retail has a target gearing range of 25 – 40%, positioning the REIT for future growth without compromising a conservative and prudent approach to capital management.

Convenience Retail is managed by APN Property Group Limited, an ASX listed company (ASX Code: APD) that has been managing real estate and real estate securities on behalf of institutional and retail investors since 1996. The REIT is governed by a majority independent Board.
