Aeris successfully completes integrated SMART building project for Dexus Property Group, which marks strategic move into accelerated revenue growth phase.

As part of a major renovation, the Willows Shopping Centre was extended from 25,000m² to 70,000m², making it the largest single story footprint shopping mall in North Queensland. This landmark project was delivered in partnership with ME Group (consulting engineering) and PEAK ARE (mechanical contractor), both being leading services companies in North Queensland.

Aeris delivered a range of control and visualisation technologies, equipment and services for the management of the Centre's temperature, lighting, ventilation, air quality and, importantly, energy usage. The Company will have an ongoing relationship with both the project and its management team, providing cloud-based data visualisation, reporting and management.
