WiseTech acquires specialist tariff compliance software provider, Digerati

WiseTech Global Limited announced the acquisition of the Digerati business (Digerati), a leading provider of tariff research and compliance tools utilised by the Australasian customs broking community.

Digerati provides its Inbound, Outbound, TradeWiseNZ and iClear Online compliance solutions to over 140 corporations including DHL, Expeditors, FedEx, Panalpina, Schenker, UPS, Yusen and many of the largest brokerage and logistics houses in Australia and New Zealand.

WiseTech Global CEO, Richard White, said "Bringing the Digerati data set and usage into the WiseTech Group now will enhance our existing pipeline development that is focused on improving border compliance. With the advent of many global border agency initiatives such as Trade Single Window, Trusted Trader, Known Shipper, C-TPAT, AEO and Supply Chain Security and the increasing need to secure borders and ensure that international trade is both safe and efficient, the work we are doing on tariff research, compliance, risk assessment and mitigation is vital to the next generation of cross-border compliance."

This adjacency acquisition is for \$6.0m and with current annual revenues of ~\$0.7m and EBITDA of ~\$0.5m this transaction is not material to the WiseTech Global group. Digerati will be included in WiseTech group accounts from 9 August 2017.

This transaction is in line with the company's stated strategy of accelerating long-term organic growth through small, targeted, valuable acquisitions across new geographies and adjacencies.
