Grant of Unlisted Employee Share Options

Buru Energy Limited ("Buru Energy") advises that the Board has approved the grant of unlisted options to employees under the Company's Employee Share Option Plan ("ESOP'). The Remuneration and Nomination Committee of the Board considers that participation in a Long Term Incentive scheme structured around equity based compensation is necessary to attract and retain the highest calibre of professionals to the Company, whilst preserving the Company's cash reserves. The purpose of the ESOP is to align the interests of employees with shareholders and to reward employees for delivering value to shareholders through share price appreciation.

The ESOP was last re-approved for a further three years by shareholders at the Company's 29 April 2015 AGM. A summary of the terms of the ESOP can be found in the Notice of Meeting for that AGM on the Buru Energy website. The Appendix 3B relating to the issue of the unlisted options is attached.

A total of 4,550,000 unlisted options have been granted to 31 employees. This grant of options would reflect $\sim 1\%$ of issued capital if all options were exercised into shares. The options have an exercise price of \$0.31, more than double the price of the recent Rights Issue. The options expire on 31 December 2019. No options have been granted to the Executive Chairman or any other Directors.
