**MANTHANO SIGNS MOU WITH TRISAKTI UNIVERSITY, INDONESIA**

iCollege Ltd (ASX: ICT) is pleased to announce that Manthano (proposed acquisition) has signed an MOU with CECT Trisakti University Jakarta.

**Key points:**

- CENTRE FOR ENTREPRENEURSHIP CHANGE and THIRD SECTOR (**CECT**), TRISAKTI UNIVERSITY has signed a Memorandum of Understanding (**MOU**) with Manthano to deliver accredited and non-accredited courses in Jakarta, Indonesia.
- The partnership will focus on the delivery of Diploma of Hospitality, Diploma of Nursing, Certificate III of Commercial Cookery and Certificate III of Hospitality as part of Phase I from facilities owned or operated by CECT.
- This is the first step in broadening the geographic footprint of Manthano into Asia, focussing on the export of Australian training resources and technology.

**CECT** is a research arm of TRISAKTI University Jakarta Indonesia. It received a grant from the Ford Foundation in 2007 for its program entitled "Business for Social Responsibility". One of the activities in this program was to design the curriculum and establish a master degree program with specialisation in CSR (Corporate Social Responsibility). Through its research and consulting works CECT supports companies and communities to bridge the gap between those who have the financial capital and those who have the social capital.

This Partnership would not only enable Manthano to deliver courses in Indonesia, but also act as a conduit to enable international students to pursue further education in Australia through and its subsidiaries and Partners. This is expected to assist in filling the Manthano CRICOS (overseas student placement) capacity.

Manthano has also entered into a partnership with Interlink Technology Services Pty Ltd (RTO 31926). Interlink Technology Services previously worked with CECT and has delivered a range of vocational programs in Indonesia in the areas of project management, risk management and consultancy. This partnership will include cooperation with Interlink Technology to deliver project and risk management programs in Australia thereby expanding the scope of course offerings.
