#### Cancellation of Vicinity Centres (ASX: VCX) securities pursuant to on-market buy-back

Vicinity Centres advises that 28,354,023 stapled securities in Vicinity Centres (**Vicinity**) have been cancelled since the last Form 484 was lodged with ASX on 17 October 2017. Following this cancellation, there are 3,871,608,967 VCX securities on issue.

A copy of the Form 484 lodged with ASIC today by Vicinity Limited (**VL**) is attached. It is noted that while each stapled security in Vicinity Centres comprises one fully paid ordinary share in VL stapled to one unit in Vicinity Centres Trust (**VCT**), the amount stated in the Form 484 as paid by VL on the cancelled shares is the amount attributed to the shares only and not to the units in VCT.
