A preliminary estimate of the 30 November 2017 Pre-Tax Net Tangible Asset Backing per share was announced on 5th December 2017. We now release the official NTA<sup>1</sup> values.

At 30 November 2017, NTA pre-tax was \$0.9997 and NTA post-tax was \$1.0073.
