## APPENDIX 3B - ISSUE OF WARRANTS

Please find enclosed an Appendix 3B in relation to the issue of 24 unlisted warrants exercisable into a number of fully paid ordinary shares (Shares) in the capital of Swick Mining Services Ltd (Swick).

On 25 May 2017, Swick announced that it had completed the acquisition of the minority shareholders' stakes in Orexplore AB (a Swedish incorporated entity) for \$2.9 million (Acquisition). Following the Acquisition, Swick now holds all of the shares in the capital of Orexplore AB (Orexplore).

Swick has issued warrants to various employees of Orexplore (8 in total). The warrants have been issued to incentivise and reward those employees in respect of their employment, and the exercise of which is subject to certain milestones being achieved regarding the product development and associated commercialisation of Orexplore technologies.

The warrants have a nil issue price and exercise price and an ultimate expiry date of 31 December 2022. Each warrant is exercisable based on certain milestones being achieved regarding the commercialisation of Orexplore, and will be exercisable into a number of Swick Shares in accordance with a formula (which relates to the externally determined equity value of the Orexplore business unit at the time of each milestone date in the future (i.e. the Valuation Date)) multiplied by a relevant percentage (being 12.5% in aggregate for all of the Orexplore employees granted warrants), divided by the volume weighted average price of Swick Shares for the 20 trading days prior to the relevant Valuation Date.
