In addition, the Company notes that following the recently announced changes to its board, it currently has two non-executive directors and therefore is not in a position to comply with ASX Corporate Governance Council Recommendation 4.1 and ASX Listing Rule 12.7, which require an audit committee of an entity in the S+P/ASX 300 Index to consist of a minimum of three non-executive directors.

The Company is currently running a process for the recruitment of additional non-executive directors. This process is expected to be concluded in the coming months, and the Company will then be in a position to comply with Listing Rule 12.7.
