## **Appointment of Teresa Engelhard as Non-Executive Director**

Chairman of WiseTech Global, Charles Gibbon, welcomed Teresa's appointment. "Teresa's extensive international operating experience in technology, innovation and M&A makes her an invaluable addition to our Board. We look forward to working together."

Teresa holds a Bachelor of Science (Hons) degree from the California Institute of Technology (Caltech), an MBA from Stanford University and is a graduate of the Australian Institute of Company Directors.

This appointment takes the number of Directors on the WiseTech Global Board to six. Teresa is considered by the Board to be independent.
