The Trust is headed by Dr L.R Yadav who is the Promoter & Chairman of the Trust, having 22 years' experience in the field of consultancy, turnkey projects, engineering, marketing and exports.

Both ICT and Alard will collaborate to provide appropriate services for the effective development and delivery of a number of iCollege programs. The MOU is not legally binding and is for the primary purpose of formalising a Heads of Agreement proceeding to a Joint Venture Agreement. The MOU is in place for a period of 90 days allowing for formal negotiations to be completed.

Initial course offerings are likely to include Hospitality courses and Bootcamps in Block Chain technology and coding.

Alard University Campus is surrounded by approximately 80 information technology companies and some 30 hotels which present an opportunity for placement of students.

The Trust is established for promoting the educational activities & programmes as well as to create job opportunities for people in the State of Maharashtra. Alard Institute is located adjacent to the Hinjewadi Information Technology Park. There are over 5000 students currently enrolled in different faculties operated by Alard which operates the following faculties:

- Alard Institute of Management Sciences
- Alard College of Pharmacy
- Alard School of Business Management
- Alard College of Engineering and Management
- Alard Public School.

Alard will provide suitable infrastructure to deliver iCollege courses with the international training delivery being conducted in Australia by iCollege at its own training facilities.
