# Link Group announces A\$300 million fully underwritten institutional placement to be followed by a share purchase plan to provide balance sheet flexibility to continue to pursue strategic opportunities

- Equity raising comprising a A\$300 million fully underwritten institutional placement and a nonunderwritten share purchase plan<sup>1</sup>
- The \$300m Placement will result in a reduction in Link Group's pro forma Net Debt to Operating EBITDA<sup>2</sup> from 2.5x to 1.6x

Link Administration Holdings Limited (ASX: LNK) (**Link Group**), a leading administrator of financial ownership data, today announces an equity raising comprising a A\$300 million fully underwritten institutional placement (**Placement**) and a non-underwritten share purchase plan<sup>1</sup> (**SPP**, and together with the Placement, the **Equity Raising**).

## Rationale and use of proceeds

Link Group has a strong track record of identifying, completing and integrating acquisitions as part of its growth strategy, having successfully completed over 40 business combinations over the last 15 years. Link Group's two most recent large scale acquisitions, Capita Asset Services (since renamed Link Asset Services, **LAS**) and Superpartners, are both on track to deliver material benefits. As previously announced, the remaining integration benefits in relation to Superpartners are expected to be

approximately a further A\$35 million by FY2020, while LAS is expected to deliver efficiency benefits of at least £15 million over the medium term<sup>3</sup>. In addition, the business has also benefited from a number of smaller bolt-on opportunities that have enhanced the client base, product suite or geographical reach of Link Group.

Highlighting growth as a primary driver of the Equity Raising, Link Group Chairman, Michael Carapiet said, "Link Group intends to continue to execute on its proven growth strategy. Net proceeds from the Equity Raising will strengthen Link Group's balance sheet and provide financial flexibility to support organic growth as well as future acquisitions."

Following completion of the \$300 million Placement, Link Group's pro forma leverage (being pro forma Net Debt to Operating EBITDA<sup>2</sup>) falls from ~2.5x to ~1.6x.

# **Placement**

The Placement to raise A\$300 million has been fully underwritten at a fixed price of A\$8.50 per share, which represents a 2.4% discount to the last closing price of A\$8.71 on 17 April 2018. New shares to be issued under the Placement will rank equally with existing fully paid ordinary shares of Link Group, except that they will not be entitled to participate in the SPP.

### **SPP**

Following completion of the Placement, Link Group will also offer eligible shareholders in Australia and New Zealand the right to participate in the SPP. If 30% of non-institutional investors participate fully in the SPP, Link Group will raise approximately A\$40 million. Link Group reserves the right to increase the size of the SPP offer or scale back applications under the SPP at its absolute discretion. The issue price under the SPP will be \$8.50 per share, which is equal to the issue price under the Placement. New shares issued under the SPP will rank equally with existing ordinary shares in Link Group. Full details of the SPP will be set out in the SPP Offer Booklet, which will be lodged with ASX and sent to eligible shareholders in due course.
