Cannabis Access, the medicinal cannabis portal for Australian healthcare professionals, is delighted to announce the appointment of Dr Sanjay Nijhawan as Medical Director.

Following on from the recent \$1million investment in Cannabis Access by MMJ PhytoTech, the appointment of Dr Sanjay Nijhawan will now allow the Company to accelerate its strategy to work with doctors throughout Australia and assist with the process of prescribing medical cannabis for appropriate patients.

Commenting on the appointment, Giles Craig, Chairman of Cannabis Access said " we are very lucky to have attracted someone of the calibre of Sanjay to our team. His expertise and proven ability to develop early stage businesses in healthcare will be important as we roll out our program helping doctors who wish to prescribe medicinal cannabis to do so efficiently."

Dr Sanjay Nijhawan is currently also a Director and shareholder of Specialist Medical Services (Australia) Pty Ltd, helping manage East Sydney Private Hospital, Sussex Street Day Surgery, George Street Eye Centre, Sydney CBD X-Ray, Cardiology group and Sydney Orthopaedics.

Previously Sanjay was Head of Clinical Development at Primary Healthcare Limited and was responsible for their very extensive network of clinics around Australia, ensuring that they were efficiently managed and adhered to best practice. Prior to working with Primary Healthcare Limited, Sanjay was the medical director and practice principle at a number of medical practices around Australia.

At the moment there are significant challenges for Australian patients who want to access medical cannabis and doctors who want to prescribe it. Based on mature markets for medical cannabis access such as California, we estimate the addressable market in Australia to be around 500,000 patients. Currently, there are only 500 patients who are legally using medical cannabis in Australia at a time when we understand up to 100,000 patients are accessing it through other means.

" We are working on a number of exciting initiatives targeting this large addressable market and will announce these as they come to fruition", Giles Craig added.
