WTC acquires US LTL TMS provider, SaaS Transportation

Global logistics solutions group, WiseTech Global, today announced the acquisition of SaaS Transportation, a specialist Less Than Truckload (LTL) transport management solution provider in the United States.

Florida based, SaaS Transportation provides LTL TMS to third party logistics companies and shippers and a specialist LTL freight rating engine with connections to LTL carriers including FedEx Freight, Con-way freight/XPO Logistics, Day & Ross Freight, Old Dominion Freight Line, UPS Freight and YRC Freight.

WiseTech Global Founder and CEO, Richard White, said "We welcome specialist LTL solution provider, SaaS Transportation, which has connections to over 70 US LTL carriers, valuable local market knowledge and US LTL road rate capabilities, to the WiseTech Global group. This transaction fits our adjacency acquisition strategy and will expand our road booking and road rates offering to our customer base."

The purchase cost comprises ~\$2.1m upfront, with a further multi-year earn-out potential of up to ~\$1.7m related to business and product integration, and revenue performance¹. With 2017 annual revenue of ~\$1.8m and ~\$0.5m contribution to EBITDA, this transaction, while of strategic value, is not material to the WiseTech Global group². SaaS Transportation is expected to be consolidated into WiseTech Global accounts from July 2018.

Along with our recent acquisitions in France, Belgium, Ireland, Germany, Italy, Turkey, North America, Argentina, the Netherlands, Brazil, Uruguay, Taiwan and Australasia, this adjacency transaction is in line with our stated strategy of accelerating long-term organic growth through targeted, valuable acquisitions.
