Trading Halt Request – Blue Sky Alternatives Access Fund Ltd (ASX: BAF)

Blue Sky Alternatives Access Fund Ltd (ACN 168 941 704) (**Company**) requests that ASX Limited grant an immediate trading halt in respect of its ordinary shares (ASX Code: BAF) in accordance with ASX Listing Rule 17.1.
