Non-executive director appointment

Cooper Energy (ASX: COE) announces that Ms Elizabeth (Betsy) Donaghey has been appointed a non-executive director of the company effective from 25 June 2018. Ms Donaghey's appointment, to a casual vacancy on the board, is to be confirmed by shareholders at the Annual General Meeting scheduled for 8 November 2018.

Ms Donaghey brings over 30 years' experience in the energy sector including technical, commercial and executive roles in EnergyAustralia, Woodside Energy and BHP Petroleum. She is also a director of Australian Energy Market Operator (AEMO).

Her board experience includes non-executive director roles at Imdex Ltd, an ASX-listed provider of drilling fluids and downhole instrumentation; St Barbara Ltd, a gold explorer and producer; and the Australian Renewable Energy Agency. She has performed extensive committee roles in these appointments, serving on audit and compliance, risk and audit, technical and regulatory, remuneration and health and safety committees.

John Conde AO, Cooper Energy's Chairman, said Ms Donaghey would provide a valuable contribution to the board's leadership of Cooper Energy's growth and development as an upstream energy company, with expanding operations and gas sales in south-east Australia.

"Ms Donaghey is an energy company director who brings relevant experience in gas commercialisation, strategy and portfolio management, sustainability and regulatory matters. These are important areas to Cooper Energy as the company builds its operations and production from its projects in the Gippsland and Otway Basins" Mr Conde said.

"On behalf of shareholders, I welcome Ms Donaghey to our board" said Mr Conde.

Ms Donaghey holds a Bachelor of Civil Engineering from Texas A&M University, a Masters of Science in Operations Research from the University of Houston and has completed the Harvard Business School Advanced Management Program.
