Gascoyne Resources Limited ("Gascoyne" or "Company")(ASX:GCY) has become aware that Mr Ian Kerr, who was appointed as an Executive Director of the Company on 21 November 2017 was required in accordance with the Company's Constitution to be re-elected at the next General Meeting which was held on 18 April 2018, and not the next Annual General Meeting as required by ASX Listing Rule 14.3. This was not performed due to an administrative oversight. The Company has conducted a review of its procedures in this area.

As Mr Kerr was not submitted for re-election at the General Meeting held on 18 April 2018 his office was deemed to be vacated at the conclusion of that meeting in accordance with the Company's Constitution. According to the Company's Constitution this oversight has no effect on any of the Resolutions the Board has passed in the period since 18 April 2018. The Director's, upon becoming aware of this administrative oversight, have today re-appointed Mr Ian Kerr as an Executive Director of the Company and will put forward his re-election at the next general meeting by special resolution as required by the Company Constitution.
