This Pay to Hold Agreement (the “**Agreement**”) is made between:

- (1) Citibank, N.A., London Branch acting as agent for the Principals (as defined below) (“**Agent**”)
- (2) Morgan Stanley & Co International plc (“**Borrower**”)

WHEREAS

- (A) The Agent acts as agent for certain Principals for the lending of securities pursuant to the Global Master Securities Lending Agreement between Agent and Borrower dated 9 February 2012 (the “**GMSLA**”).
- (B) The Borrower from time to time borrows securities from the Agent acting as agent for the Principals pursuant to the **GMSLA**.
- (C) The parties wish to agree that in certain circumstances, the Borrower shall pay a fee to the Agent to hold or reserve certain securities belonging to the Principals, with the right to borrow those Securities in accordance with the terms of the **GMSLA** (a “**PTH Arrangement**”).
- (D) Any capitalized terms used herein but not expressly defined in this Agreement shall have the meaning given to them in the **GMSLA**.

It is agreed as follows:

1. Agreement to Pay to Hold

- (a) From time to time, Agent and Borrower may agree the Terms (as defined below) of a PTH Arrangement (which may be on an open for fixed term basis) for a security or securities (“**Securities**”) by authenticated message such as Bloomberg, which shall be, absent proven error, prima facie evidence of the terms of the PTH Arrangement. Agent shall ensure that Securities in a PTH Arrangement will be available from a Principal approved by Borrower through [Agency Lender Disclosure].

Where the parties agree that a PTH Arrangement is “open”, the parties shall on each Termination Date enter into a new PTH Arrangement on the same terms as the arrangement expiring on that date; provided that either party may give notice on any date (with immediate effect) that no such new arrangement shall be entered into.

In respect of each PTH Arrangement, the fee payable by the Borrower shall accrue daily in respect of the period commencing on and inclusive of the Commencement Date and terminating on and exclusive of the Termination Date. Unless otherwise agreed, the sum so accruing in respect of each PTH Arrangement shall be paid by arrears by the Borrower no later than the Business Day which is the tenth Business Day after the last Business Day of the calendar month to which such payments relate or such other date as the parties shall from time to time agree. If a corporate action occurs in relation to Securities subject to a fixed term PTH Arrangement, the parties shall discuss in good faith an adjustment to reflect such action.

- (b) In this Agreement,

“**Commencement Date**” means, in respect of a PTH Arrangement for any particular Securities, the date agreed between the parties;

“**Termination Date**” means, (i) in respect of a fixed term PTH Arrangement for any Securities, the termination date agreed between the parties and (ii) in respect of an open PTH Arrangement, the first Business Day following the Commencement Date.

“**Terms**” means, in respect of each PTH Arrangement, (i) whether the PTH Arrangement shall be on an “open” or “fixed term” basis; (ii) the Commencement Date, (iii) where the term is “fixed”, the Termination Date and (iv) the fee (expressed as a rate applied to the daily Market Value of the relevant Securities) payable by the Borrower.

2. Borrowing of Securities

- (a) If the Borrower elects to borrow Securities, the Agent will procure the Delivery of such Securities on the agreed Settlement Date and as of the Settlement Date there shall be a Loan which shall be governed by the terms of the

GMSLA. Until Securities are transferred on a Settlement Date in respect of a Loan, the PTH Arrangement in respect of such Securities shall be governed solely by this Agreement.

- (b) Where a PTH Arrangement in respect of particular Securities is on a fixed term basis and (i) all or a portion of those Securities are transferred to the Borrower on a Settlement Date under the GMSLA, and (ii) Equivalent Securities are redelivered by the Borrower to the Agent during the term of the relevant PTH Arrangement, those Securities shall, upon redelivery, become subject to the relevant fixed term PTH Arrangement and shall be available to borrow by the Borrower in accordance with sub-paragraph (a) above.
- (c) For the avoidance of doubt, no Loan shall arise in respect of any Securities unless Borrower elects to borrow such Securities and the relevant Settlement Date has occurred.

3. Right of Principals to Withdraw Securities/Termination due to Failure to Deliver Securities

- (a) Except in respect of Securities which are subject to a fixed term PTH Arrangement, the Agent reserves the right to withdraw some or all of the Securities at any time with immediate effect and the Agent undertakes the responsibility to inform the Borrower of such event.
- (b) In respect of Securities which are subject to a fixed term PTH Arrangement, if the Agent fails to deliver the Securities to the Borrower on a Settlement Date in accordance with paragraph 2(a) above the relevant fixed term PTH Arrangement shall terminate immediately and no further fees in respect of such fixed term PTH Arrangement shall be payable by the Borrower.
- (c) Upon termination of a fixed term PTH Arrangement pursuant to para 3(b) above, the Borrower shall be entitled to a rebate of any fees already paid to the Lender and the Lender shall promptly refund such fees to the Borrower.

4. Representation of Borrower

Borrower represents and covenants for the benefit of Agent and the Principals that the arrangements contemplated hereby are intended to assure Borrower the availability of securities for a potential loan and are not and shall not be used to circumvent takeover/ position reporting laws, foreign ownership limits, portfolio reporting requirements or any similar laws or regulations.

5. Termination

Either party may terminate this Agreement by giving prior written notice to the other party; provided that the parties' respective obligations in respect of any fixed term PTH Arrangement shall continue until the relevant Termination Date.

6. Governing Law

This Agreement and any non-contractual obligations shall be governed by the laws of England and Wales.
