DELIVERIES OF THURAYA WE DEVICES TO COMMENCE

World Reach Limited is pleased to announce that its wholly owned subsidiary, Beam Communications Pty Ltd, has received the necessary approvals to commence shipment of the Thuraya WE product, following resolution of all blocking issues with the terminal's firmware.

As previously advised, issues with the internal module's firmware caused delays in the final upload of the Thuraya WE devices, which required consecutive revisions to enable those performance issues to be addressed. These have now been rectified and the updating of all the terminals firmware has commenced.

The shipment of finalised product, which has been eagerly anticipated by our client and the market generally, will commence shortly, although the majority of the first order of 3,000 terminals will now ship in the second quarter of FY2019.

CEO Michael Capocchi said:

"This is a great milestone for our Company. The WE product is innovative, it significantly augments Beam's product suite and it is expected to be very well supported in the market. Its finalisation is a great credit to our staff and the whole project team".

A further update will be provided to the market to confirm shipments have commenced, as soon as Thuraya takes delivery of the first shipment, anticipated very early in quarter two.
